1. In 2020 there will be four vacancies on the Board according to the rotation prescribed by the Constitution.
2. The SPBA Board comprises seven elected directors; and up to two Board appointed directors.
3. The director incumbents whose terms expire at the 2020 AGM are all entitled to stand for re-election.
4. There are twelve Board Meetings per year held monthly, at every third Thursday of the month at an agreed upon location.
5. SPBA is committed to diversity and inclusion in all its business and activity areas and welcomes nominations from people that align with our Association Vision.
6. SPBA is committed to providing a child safe environment within our sport. Successful nominees will be required to undertake a Working with Children Check, National Police Check and Statutory Declaration. As per SPBA's Member Protection Policy they will undertake training in Child Protection and agree to relevant Code of Conducts.
